From 30th October 2024, SGX is expanding our suite of Singapore Depository Receipts (SDR) to cover Hong Kong stocks with the introduction of 5 new names: Alibaba (HBBD), Tencent (HTCD), BYD (HYDD), HSBC (HSHD), Bank of China (HBND).

The suite of HK SDR provides thematic exposures to evolving global trends in AI transformation, EV transition and financials, allowing investors to flexibly diversify their portfolios. **HK SDR differentiates** from traditional route of access with key benefits being.
